1. Who is responsible for processing your personal data?

2. What personal data do we process, for how long, and for what purposes? We will only process your personal data to the extent necessary to ensure the proper functioning of this website, ensuring you can use all its features and the provision of our services, in accordance with the General Data Protection Regulation ("GDPR"), Law No. 58/2019 of August 8, 2019 (which ensures the implementation of the GDPR in national law), Directive 2002/58/EC of July 12, 2002 (directive concerning the processing of personal data and the protection of privacy in the electronic communications sector), Law No. 41/2004 of August 18 (which transposes Directive 2002/58/EC into national law), and other applicable privacy and personal data protection legislation.

Your personal data will be deleted or anonymized once the purposes that justified their processing cease, except in situations where the law or a legitimate reason justifies or requires their retention for longer periods.

We will provide you with all the information about the processing of your personal data, including the respective purposes, legal bases, categories of personal data involved, and applicable retention periods. We will also provide information about your rights regarding personal data protection and the technical and organizational measures we adopt to ensure your privacy.

1. Creation and management of an online account

3. To whom may we transmit your personal data?

Whenever these companies process your personal data on our behalf and under our instructions, we ensure the same level of security and privacy in such processing.
